BP/UPTI PROGRAM

The Buried Piping and/or Underground Piping and Tank Integrity (BP and UPTI) programs were developed in order to track and trend wall loss within piping and tanks that are buried (in contact with soil) and underground (within tunnels, trenches, or vaults). Currently, the Underground Piping and Tank Integrity Initiative (UPTII) has been issued by the Nuclear Energy Institute (NEI) in order to establish milestones for the development of a through and rigorous program in order to reduce leaks from lines which contain license radioactive and environmentally sensitive material. Historically, buried / underground piping and tanks have not been well maintained or monitored for potential degradation. Experience has shown both fossil and nuclear stations that have experienced leaks can lead to costly outages, clean-ups and repairs.
